The maximum funding should be claimed only where a learner is following a full-time qualification that is delivered in 450 or more glh.

In determining the appropriate funding rate to be claimed for an individually listed NVQ, colleges and providers should consider the following.

Which of the three components are delivered by the provider?

How many glh are delivered? Where the provider delivers all aspects of the NVQ model 1 but in fewer than 450 glh, the national rate will be £1,182.

What is the length of time over which the programme is delivered?

Is there an overlap in content with any other NVQ or other qualification that is part of the learner's programme of study?

For provision delivered entirely in the workplace colleges and providers must be able to demonstrate the delivery of actual glh as distinct from work-related supervision.
